




Sea Country Indigenous Protected Areas (IPA) Program

- Australian Government Oceans Leadership Package
- Increase the area of sea and coastal areas in IPAs
- Strengthen conservation and protection of Aboriginal Heritage, and marine and coastal environments
- Create employment and economic opportunities for Indigenous people
- Expands Wardang Island IPA (1 of 10 projects)

• Activities include

- pest plant and animal control both coastal and marine
- access management
- surveillance
- environmental monitoring
- research

Cultural significance of beaches and dunes

- Burial sites
- Fire and camp sites
- Middens
- Springs, soaks and wells
- Tools
- Trade artefacts





## Yorke Peninsula Council – Coastal issues

- Sand dune degradation (loss of protective native vegetation cover exposing sand, resulting in sand drift) and potential resultant degradation to Narungga Heritage, due to:
  - Vehicle use (including development of tracks) and camping
  - Camper's & beach user's pedestrian activity including:
    - Toileting
    - Photography
    - Seeking mobile reception
    - Playing i.e dune sliding etc

## Coastal issues (continued)

- Impacts to wildlife such as beachnesting birds (known nesting of Hooded Plovers)
- Beach compaction (as a result of vehicle use)
- Ocean pollution
- Mismanaged camp fires
- Potential introduction of weed species



#### YPC Coastal Management Strategy

 The Coastal Management Strategy provides communitysupported directions and actions for coastal open space (either owned by or under the care, control and management of Council), providing guidance on the most appropriate ways to enhance opportunities for coastal access and recreation in balance with landscape, heritage and biodiversity protection.
